

## FORMER TRUSTEES

**Dr George Zeidenstein** is the former CEO of the Population Council and a Distinguished Fellow at Harvard University's Centre for Population and Development Studies. He has addressed a wide spectrum of international development issues during his career, including years of residence in Nepal as Country Director of the Peace Corps, and in Bangladesh as Resident Representative of the Ford Foundation. He served as the Alliance's founding chair in 1993 and on the Board of Trustees until 2006.

**Carl Wahren** began his career as an Assistant Professor in Political Science and International Politics at Stockholm and Uppsala universities. He then worked for the Swedish International Development Corporation and the Organisation for Economic Co-operation and Development before becoming Secretary General of the International Planned Parenthood Federation and a consultant to the United Nations Population Fund and the World Health Organisation. He was a founding member of the Board of Trustees in 1993 and served until 2004.

**Prof Fatou Sow** is Professor of Sociology at the Université Cheikh Anta Diop de Dakar. In 1994, she helped set up the Gender Institute at the Council for the Development of Social Science Research in Africa and is the current Director of the International Solidarity Network Women Living Under Muslim Laws. She was a founding member of the Board of Trustees in 1993 and served until 2008.

**Joan Lestor** was a celebrated Labour politician who spent her career campaigning the rights of women and opposing apartheid. In 1974, she was appointed a junior minister in the Foreign Office with special responsibility for African affairs and was chair of the Labour Party between 1977 and 1978. She was created a life peer as Baroness Lestor of Eccles in 1997 and died in 1998. She served on the Board of Trustees between 1994 and 1996.

**Prof Olikoye Ransome-Kuti** was a leading paediatrician and one of Nigeria's most celebrated health ministers. In 1986, he conveyed word of Nigeria's first HIV case and was instrumental in raising awareness about HIV in the country. He was Minister of Health between 1985 and 1992 where he made qualitative healthcare available to every Nigerian, introduced free immunisation for children, and developed family planning programmes. He became the World Health Organisation's Deputy Director-General and a visiting professor at Johns Hopkins University. He served on the Board of Trustees from the Alliance's inception in 1994 until 2003, the year of his death.

**Kaval Gulhati** is a senior population and development specialist with more than 30 years of experience in health and demography, institutional development, training, project management, programme design and implementation in Asia, Latin America, Africa and the Middle East. She co-founded and served as President and CEO of the Centre for Development and Population Activities in Washington, and co-founded the Unniti Foundation, where she remains its chair and President. She served on the Board of Trustees from the Alliance's inception in 1994 until 2006.

**Kevin Ryan** was previously the volunteer project director of the global HIV education programme, 'Positive Lives' as well as a former trustee of the HIV information charity NAM. Kevin was previously a partner on the international board of a leading London law firm and a past president of an international business association. He is HIV positive and combines a professional legal career with work as a volunteer lawyer with a variety of organisations. Kevin served on the Board of Trustees from 2008 to 2012.

**Dr Fleur Fisher** is an independent consultant in ethics and healthcare practice. She has served as co-chair of the Education and Training Working Group on Integrated Healthcare at the Prince of Wales Initiative; chair of the British Medical Association's (BMA) Foundation for AIDS; co-chair of the Prevention of Professional Abuse Network and President of the Medical Women's Federation. Between 1991 and 1996 she was Head of Ethics, Science and Information for the BMA. She served on the Board of Trustees between 1996 and 2008.

**Teresita (Bai) Marie P. Bagasao** is *UNAIDS Philippines Country Director* and founding chair of the Board of PHANSuP (the Alliance linking organisation in the Philippines). Before UNAIDS, Bai worked as a senior trainer on community organisation at Philippine State University. For ten years, she worked on sexual and reproductive health and maternal and child health for various NGOs and championed the empowerment of key populations to be advocates in Philippine's HIV response. She served on the Board of Trustees between 2002 and 2011.

**Peter Freeman CBE** is a former Director of Finance and Aid Policy at the UK Department for International Development (DFID). Before this role, he served as DFID's Africa Director. After leaving DFID in 2001, he became an honorary treasurer of the Institute for Development Studies at Sussex University. He served on the Board of Trustees between 2002 and 2011.

**Dr Nafis Sadik** is a former Special Adviser to the UN Secretary General with additional responsibilities as Special Envoy for HIV/AIDS in Asia. She previously headed up the United Nations Population Fund. Before joining the United Nations, Dr Sadik was Director-General of the Pakistan Central Family Planning Council. A Doctor of Medicine, she has served as a civilian medical officer in various Pakistani army hospitals. She sat on the Board of Trustees between 2005 and 2014, at which point she was appointed Trustee Emeritus.

**Prof Callisto Madavo** is a noted Zimbabwean economist. He served at the World Bank for 35 years where he held several senior positions including Vice President for the Africa Region, in charge of 47 sub-Saharan countries, and Country Director for East Asia and East Africa where he championed HIV initiatives. In 2014, he became chair of the Africa Capacity Building Foundation's Executive Board. He served on the Board of Trustees twice, from 2005 to 2010 then again from 2011 to 2015.

**Dr Jacob Gayle** is the Vice President of Medtronic Philanthropy and has held senior positions in several of the world's leading health, development and philanthropic institutions including Deputy Vice President of the Ford Foundation and Senior Public Health Officer for the US Centre for Disease Control and Prevention. He has also worked for the United States Agency for

International Development, the United Nations and the World Bank. He served on the Board of Trustees between 2005 and 2006.

**Dr Steven Sinding** was Director-General of the International Planned Parenthood Federation. Prior to this, he held a variety of positions relating to population, health and nutrition. Following a 20-year career at the United States Agency for International Development, he served as Population Advisor to the World Bank, Director of Population Sciences for the Rockefeller Foundation, and Professor of Population and Family Health at Colombia University. He served on the Board of Trustees between 2006 and 2015, including seven years as chair.

**Jacqueline Rocha Côrtes** is a HIV activist and a UNAIDS representative. A transwoman living with HIV, she works closely with health professionals and politicians to ensure the voices of affected communities are considered in Brasil's HIV response. She is a founder of the Brazilian Network of PLWA and a member of Positive Women Citizens, a former board member of the World Aids Campaign Global Steering Committee, and a former representative on the GNP+ Board. She served on the Board of Trustees between 2007 and 2009.

**Fatimata Sy** is the Coordination Unit Director for the Ouagadougou Partnership, a regional coalition expanding family planning in nine francophone nations of West Africa. The Ouagadougou Partnership began in 2011 and is helping countries reposition family planning through increased donor and government coordination. She served on the Board of Trustees between 2008 and 2013.

**Jan Cedergren** has been Deputy Director General of the Swedish International Development Cooperation, Director General for International Cooperation in the Swedish Ministry for Foreign Affairs, and Director of Operations at the Office of the High Commissioner for Human Rights. He chaired the Organisation for Economic Cooperation Development's DAC Working Party on Aid Effectiveness and negotiated the Accra AAA-agreement in 2008, involving about 120 countries and organisations. He served on the Board of Trustees between 2008 and 2014.

**Prof Carmen Barroso** is Regional Director of the International Planned Parenthood Federation. She was a Professor of Sociology at the University of

Sao Paulo, Brazil and a senior researcher with the Carlos Chagas Foundation, where she created Brazil's first women's studies centre. A former Director of the MacArthur Foundation's Population and Reproductive Health programme, she has served on several boards including the Millennium Project Task Force and the Brazilian Commission on Reproductive Health. She served on the Board of Trustees between 2010 and 2014.

**Carole Presern** has more than 25 years' experience in governance, management, international health policy and health in developing countries, and has worked for the UK Foreign and Commonwealth Office and the UK Department for International Development on issues including health and AIDS policy, human rights and policy development. In October 2014 Carole joined the Global Fund to Fight AIDS, Tuberculosis and Malaria as the new Head of the Office of Board Affairs. Prior to this she served as Director of The Partnership for Maternal, Newborn and Child Health (PMNCH). Carole was a member of the secretariat's Policy and Advocacy Committee. She served on the Board of Trustees between 2008 and 2017.

**Kanini Mutooni** has over 14 years of audit and risk management experience in the Financial Services sector, most recently in the position of Director of Internal Audit and Governance at Kleinwort Benson Bank. She is currently Director of ICT and Investment at the East Africa Trade and Investment Hub, a USAID project under the Trade Africa initiative to boost trade with and within Africa. Kanini is an MBA holder and Chartered Accountant. Kanini is the founder of myAzimia.org, a software company that provides a white label technology solutions for the crowd-funding, Peer-to-Peer lending and microfinance sectors. She served on the Board of Trustees as the Chair of the secretariat's Finance and Audit Committee between 2012 and 2017.

**Jens Van Roey** worked as a medical doctor for 10 years in clinical care settings in the Democratic Republic of Congo and then in the field of technical assistance for HIV programming at the national level, before becoming Programme Officer for the African region for UNAIDS. He is currently Director: Global Clinical Development at Tibotec, focusing on the development of vaginal microbicides for the prevention of sexual transmission of HIV, and is also a member of the Scientific Advisory Board of the International Partnership for Microbicides. He has been living with HIV for more than 20 years.

**Kieran Daly** has an academic background in development economics, and is currently Deputy Director of Program Advocacy and Communications at the Bill & Melinda Gates Foundation. He served as the Chief Executive Officer of the International Council of AIDS Service Organizations (ICASO), and has also worked previously for the International HIV/AIDS Alliance as Senior Policy Advisor. Kieran served on the Board of Trustees between November 2016 and November 2018.
